

- Includes Regional Corridor Transportation Plan (2022)



#### Other Business

#### **USDOT RAISE Grants**

The RAISE program supports multimodal and multijurisdictional rail, road, transit, and port projects that are usually harder to support via traditional USDOT programs. These grants are intended to support projects that reflect national objectives. The previous RAISE grant cycle contributed significant funds toward trail and active transportation infrastructure, helping make walking, biking, and riding more safe and equitable.

#### FHWA Bridge Investment Program, Planning and Bridge Project Grants

USDOT is accepting applications for two funding categories: (1) Planning and (2) Bridge Project grants (a project with total eligible costs not greater than \$100 million) for awards under the Bridge Investment Program (BIP). The goals of the program are to 1) improve the safety, efficiency, and reliability of the movement of people and freight over bridges; 2) improve the condition of bridges in the United States; and 3) provide financial assistance that leverages and encourages non-Federal contributions from sponsors and stakeholders involved in the planning, design, and construction of eligible projects.

#### **USDOT Rural Autonomous Vehicle Program**

Recipients will use Rural Autonomous Vehicle program funding to conduct research regarding the benefits and responsible application of automated vehicles and associated mobility technologies in rural and Tribal communities. One \$15 million award will focus on passenger transportation, and a separate \$10 million award will focus on movement of freight to support and enable automated freight and delivery vehicles serving rural areas.

#### NHDES Request for Public Comment on Draft Priority Measures for NH Priority Climate Action Plan

The PCAP is a report that includes a focused list of New Hampshire's near-term, high-priority, and implementation-ready measures to reduce GHG emissions in the state. The PCAP is a pre-requisite for competing in the second phase of the CPRG program, during which EPA will competitively award \$4.3 billion in grants for implementation of measures listed in a PCAP. Comments are due by 4 PM on February 20, 2024

#### **TRB Report on Critical Issues in Transportation**

The report focuses on five goals to meet the major challenges facing society: (1) Mitigating and responding to climate change, (2) Promoting equity and inclusion, (3) Increasing road safety, (4) Advancing public health, and (5) Building and sustaining a strong, competitive economy.
