 - a. Dick Jones motioned to approve the minutes; Adams Carroll seconded. Liz Emerson abstained. The minutes from February 21st were approved 9-0-1.
- III. FY 2025-2034 Ten-Year Plan Updates**
 - a. Cass explained how the TYP projects in our region need a final ranking submission to NHDOT. As a reminder, the preliminary scores were the following: Lebanon’s Hanover Street scored 72.5/100, Claremont’s Main Street scored 71.2/100, and Newport’s Park and Ride scored 43.8/100. Cass explained that Newport’s Park and Ride received a CMAQ funding award. The Committee discussed these scores and the projects. TAC members discussed the criteria and criteria weighting discussing similarities and differences between the Lebanon and Claremont projects.
 - b. Liz Emerson motioned to recommend that the UVLSRPC Full Commission submit the preliminary rankings as final rankings for inclusion in the FY25-34 Ten-Year Plan; Dick Jones seconded. The motion was approved 9-1-0.
